### ORDINANCE 2025-2 TAX LEVY ORDINANCE

# THE BOARD OF LIBRARY TRUSTEES OF THE FOX RIVER GROVE PUBLIC LIBRARY DISTRICT

## MCHENRY COUNTY, ILLINOIS FOR THE FISCAL YEAR COMMENCING JULY 1, 2025 AND ENDING JUNE 30, 2026

WHEREAS, applicable statutes require the Fox River Grove Public Library District to adopt a levy ordinance levying taxes for Library District purposes upon all property subject to taxation within the Library District; and

WHEREAS, pursuant to applicable statutes, a Budget and Appropriation Ordinance was previously adopted, published, and filed.

NOW, THEREFORE, BE IT ORDAINED by the Board of Library Trustees of the Fox River Grove Public Library District as follows:

Section 1. The Budget and Appropriation Ordinance for the fiscal year 2025-2026 is incorporated by reference.

Section 2. A tax in the sum of SIX HUNDRED TWO THOUSAND ONE HUNDRED FOUR DOLLARS AND ZERO CENTS (\$602,104.00) is levied as follows:
